JULY 2020 BUILDER PROMOTION

TERMS AND CONDITIONS

NNP-Looper Lake, LLC ("Sterling on the LakeTM"), the fee owner of Sterling on the LakeTM, and D.R. Horton, Inc., the builder of certain homes at Sterling on the LakeTM described herein, ("Builder"), desire to promote the sale of houses at Sterling on the LakeTM. Accordingly, the following Terms and Conditions set forth govern Sterling on the LakeTM's July 2020 Builder Promotion (the "Promotion").

1. <u>Sponsor of Promotion</u>

2. Management of Promotion

4. <u>Time Period</u>

This Promotion is limited to Eligible Houses, as described above, which are: (1) sold between July 15, 2020, and August 15, 2020, *and*; (2) complete closing before September 30, 2020.

5. <u>Promotion Incentives</u>

Purchasers of Eligible Houses during the Promotion time period, as described above, ("Purchasers" or "Participants"), will be entitled to the following financial incentives ("Promotion Incentive"), at their discretion:

6. **Builder's Obligations**

- a. <u>Providing Information to Purchaser:</u> Builder will be solely responsible for providing Purchasers with information regarding their two Promotion Incentives options, as described above, at closing.
- b. <u>Memorializing Purchaser Selection:</u> Builder will memorialize each Purchaser's selection in writing, and incorporate that selection as part of the closing documents for each Eligible House.
- c. <u>Delivery of Selected Promotion Incentive</u>: Builder will be solely responsible for the delivery of selected Promotion Incentives to each Purchaser. Such delivery shall be completed at the time of closing.

7. <u>Sterling on the LakeTM's Obligations</u>

Sterling on the LakeTM shall in no way be responsible for Promotion Incentives owed to Purchasers pursuant to this Promotion. Builder and Purchaser expressly waive any claims of liability against Sterling on the LakeTM arising from obligations to Purchasers under this Promotion.

8. <u>Applicable Law</u>

These Terms and Conditions shall be construed and interpreted under the laws of the State of Georgia.

9. Purchaser Eligibility

The Promotion is open only to legal residents of the State of Georgia and United States who are 18 or older as of the commencement of the Promotion. Current residents or occupants of a home in Sterling on the LakeTM are not eligible to participate. Employees, contractors, or agents of Sterling on the LakeTM, or of any Builder or any of their parent companies, affiliates, agents, or subsidiaries, as well as the immediate family (spouse, parents, siblings, and children) and household members of such employees, contractors or agents, are not eligible to participate. Void where prohibited. Details and qualifications for participation in the Promotion apply and are set forth in these Terms and Conditions.

10. Agreement to Terms and Conditions

Participation in the Promotion constitutes full and unconditional agreement to and acceptance of these Terms and Conditions, as may be amended from time to time in the sole and absolute discretion of Sterling on the LakeTM. All applicable federal, state and local laws and regulations apply. By participating in the Promotion and/or accepting a Promotion Incentive, each Participant agrees: (i) to release and hold Sterling on the LakeTM, North America Sekisui House, LLC ("NASH") and their affiliates, all Builders, and each of their affiliates, subsidiaries, parent companies and agents, officers, directors, shareholders, partners, members, employees, contractors and agents (collectively the "Released Parties"), harmless from and against any and all claims and liability arising out of participation in the Promotion, and to hold the Released Parties harmless against any and all claims and liability arising from the use, redemption, or delivery of any Promotion Incentive, (ii) to be bound by the Terms and Conditions, and the decisions of Sterling on the LakeTM in all regards, which are final in all respects, (iii) that the Released Parties are not responsible and do not assume liability for any injury or damage caused, or claimed to be caused, by participation in this Promotion or use or redemption of Promotion Incentives, and (iv) that the Released Parties do not operate or control in any respect any products, or services provided by any third party vendor.

NASH and Sterling on the LakeTM shall not be held liable or responsible for failure or delay in fulfilling or performing any obligations in these Terms and Conditions to the extent and for so long as such failure or delay is caused by or results from causes beyond their reasonable control. NASH Sterling on the LakeTM are not responsible for any typographical or other error in the printing of the Promotion.

TO THE FULLEST EXTENT ALLOWABLE BY LAW, ALL THIRD PARTY SERVICES AND/OR MERCHANDISE ARE PROVIDED "AS IS" WITHOUT ANY WARRANTY WHATSOEVER FROM NASH OR STERLING ON THE LAKE™, AND NASH AND STERLING ON THE LAKE™ SPECIFICALLY DISCLAIM ANY REPRESENTATIONS OR WARRANTIES, EXPRESS OR IMPLIED, REGARDING THE SERVICES AND/OR MERCHANDISE OFFERED THROUGH THE PROGRAM INCLUDING ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE AND IMPLIED WARRANTIES ARISING FROM COURSE OF DEALING OR COURSE OF PERFORMANCE.

12. Social Media

Any and all claims, judgments and rewards shall be limited to one-thousand dollars (\$1,000.00), and shall expressly exclude any award of attorneys' fees; and under no circumstances will any Participant be permitted to seek recovery for, and Participant hereby waives all rights to claim, punitive, incidental and consequential damages and any other damages, other than for the actual value of the Program Incentive, and waives any and all rights to have damages multiplied or otherwise increased.

Homebuyers waive, to the fullest extent permitted by law, any and all rights, claims, causes of action and other rights whatsoever against Sponsor and its affiliates arising out of their purchase transaction with the Builders.

NASH and Sterling on the LakeTM, their affiliates, subsidiaries, parent companies and agents, officers, directors, shareholders, partners, members, employees, contractors and agents shall have no (i) liability whatsoever with respect to the development of Sterling on the LakeTM or the selling of homes by the Builders, and (ii) responsibility for any claims, issues or matters arising at Sterling on the LakeTM.

Neither Sterling on the LakeTM nor its affiliates is a guarantor or party to any of the agreements between the Builders and third parties, including homebuyers. Homebuyers shall look solely to the Builders with respect to any claims or issues arising out of their purchase of a home in Sterling on the LakeTM.
